Who Are We

The My Body Is My Body Foundation ("MBIMB", "we", "us", "our") is a registered charity in England and Wales (Charity No. 1199901).

What Information Do We Collect

We collect personal data that you voluntarily provide, including:

- Name, email address, phone number, and country of residence
- Details provided when joining as an Ambassador, Presenter, or volunteer
- Course enrolment details and progress (if you use our online training)
- Messages, photos, or documents shared via email, WhatsApp, or website forms

How Do We Use Your Information

- Communicate about MBIMB activities, courses, and updates
- Manage Ambassador, Presenter, and volunteer participation
- Administer and improve our online learning systems
- Fulfil legal obligations for charity governance and record-keeping

Legal Base For Processing

We process your data under one or more of the following lawful bases:

Consent - when you opt in to communications or submit a form

Legitimate Interests - for managing volunteer engagement or course delivery

Legal Obligation - to comply with charity or statutory requirements

How Do We Store And Protect Your Data

We may share limited data only with trusted service providers who help us operate our website, courses, or communications, for example:

- WordPress (website and course hosting)
- Google Drive, Gmail, Analytics
- WhatsApp or equivalent communication tools

Each provider is bound by a Data Processing Agreement and must comply with data-protection law. We never share data for marketing purposes.

International Data Transfers

Some trusted service providers (for example, Google Drive, WhatsApp) may store or process data outside the UK or EEA.

When this occurs, we use UK-approved Standard Contractual Clauses or equivalent protections to keep your information secure.

Children's Privacy

We do not knowingly collect personal data directly from children.

Any photos, videos, or materials featuring children are shared only with parental or guardian consent and are handled with strict oversight.

Cookies

Our website uses cookies to enhance your experience. You can adjust your browser settings to refuse cookies if you prefer.

Embedded Content

Articles on our site may include embedded content (for example, videos or images) from other websites, which may collect data about you or track interactions as if you visited those sites directly.

How Long Do We Retain Your Data?

- Comments and their metadata are retained indefinitely for moderation purposes.
- Registered user data is stored as long as the account remains active.
- We regularly review and delete unnecessary data in line with legal retention requirements.
